This deed of the trust which is known as BIRSA EDUCATION TRUST, settled and formed on 3<sup>rd</sup> October 2001 by Smt. Soni Devi wife of Dr. Birsa Oraon resident of Buti Road, Ranchi, Jharkhand is going to be submitted this day before the registrar of Ranchi Jharkhand for registration to regularize and legalize it under Indian trust act 1882 for its existence for times to come and for ever service.

Now Smt. Soni Devi (hereinafter called the founder of Birsa Education trust ) on the one part and the person whose names have been given in appendix "A" ( hereinafter called the remaining trustees) which expression shall include the administrators and executors of the remaining trustees for the time being of the foundation, hereby going to be registered on the other part.

The head office and the registered office will be located in Ranchi, in the State of Jharkhand.

Whereas the founder has decided to form a foundation by transferring and donating Rs. 1000/- ( Rupees One thousand only ) of his property in the cause mentioned below. To achieve the said desire the founder frames the following ways and means to use, and execute the foundation in the below mentioned cause and also dedicate the foundation to the following objective :-

1. It shall be purely charitable public organization to serve, volunteer and help the sufferers without making any reservation, demarcation of any nature in the world.
2. It will undertake, maintain, open and run centers to serve the entire living beings, in the world.
3. It will build, establish, undertake, maintain open and run educational institutions, adult education, hospitals dispensaries, hostels, homes for poor and sufferers in the country.
4. It will build, establish, undertake, maintain open and run such industrial, commercial and manufacturing units where sufferers, handicapped deserted socially and economically backward, aged and the needy can earn their livelihood with prestige and without being a burden on others.
5. It will do such work, programmes or to convene meetings, seminars, conferences etc. by which peace and prosperity in the country can be brought and maintained.

- 6. It will seek and accept donations, grants offerings, voluntary services, subscription, contribution and may seek and negotiate to get loans from the financial institutions, banks, individuals and deal with the same for the objectives and programmes of the foundation.
- 7. It will invest, dispose off, transfer, enter into agreement, contract and otherwise deal with regular business, subject matters, funds, resources, assets, of the foundation in such manner as the board of trustee will deem fit in running and managing the affairs of the foundation.
- 8. It will and can undertake and perform any other programmes supplementary to the objectives of the foundation or as decided by the board of trustees.
- 9. It will appoint, terminate, suspend staff for the purpose of the foundation; to achieve its objectives and as per need.
- 10. It will be governed for all its practical and legal purpose by the Indian trust act 1882.

And it is hereby declared that all or any of the power vested in or exercisable by the board of trustee herein under shall be complete if being performed by majority opinion of the trustee and decision of such majority shall be valid, binding effective as if it would have been done by all the trustee together.

That the trustee jointly shall manage the objective of the foundation as economically as they can with circumspection as they may jointly or in meeting resolve by majority, but no decision will be taken by the trustees contrary to the objective of the foundation, so long as founder is alive, the trustee may seek his advice in case of confusion and dispute, whose decision would be final.

The trustee has vested the ownership and possession of all the properties of the foundation in the trustee jointly to run and administer the foundation by nominating the person as shown in the appendix "A" as trustees and the founder constitute and nominate himself as one of the trustee for his lifetime with right of casting vote and after his death or retirement his successor or nominee will succeed to him and shall be one of the trustee in the board of trustee.

Now this deed witness as follows :-

In pursuance of the said desire the founder hereby transfers and assign all the properties and assets mentioned in appendix "B" and all the estate, right, title interest, property, claim and demand whatsoever in the same to have and hold the same to have and hold the same to and upto the trustee absolutely and for ever management of the foundation and for the purpose mentioned in the deed without reserving any pecuniary benefit for himself and his heirs and descendants in the manner herein after

That in case of retirement, resignation death or removal for any reasons of any of the above trustees aforesaid, the vacancy will be filled up by nomination to be made by the founder till his life time and after his death by nomination/invitation as per decision of all the remaining trustees to keep and maintain seven trustees in all. The founder shall have the right to appoint another in his place if such a need arises in the working of the foundation.

The trust shall be governed by a Board of Trustees. The Board of Trustees shall consist of all the trustees the number of which shall always be not less than 3 and not more than 15.

The trustees may elect or nominate 3 persons, one each as the The Chairman, Secretary and the Treasurer of the Board of Trustees. The Chairman, Secretary and Treasurer may be appointed for period not exceeding 3 ( Three ) Years. The first Chairman to be initially elected unanimously by the Board of Trustees.

The Board of Trustees shall have power to frame The Bye-Laws for internal Administration of the foundation, its institution, programmes, Projects etc. and can do Amendments, addition therein as per need, time to time for smooth working and running of the foundation. And for all other purposes which are not covered by this deed the Indian trust act 1882 will be followed.
